### **Entrance/Exit Area Postponed**

Dear Residents,

Oahu Sealcoating and Paving notified us that the road reconstruction for the entrance/exit area of Laukahi Street has been postponed. This is the last phase of the project and after this the project will be complete.

Please see below for updated schedule:

- **Entrance/Exit- Guard Station:**  
July 31st -August 1st\*  
Half of road closed each day from 8am-5pm\*

Road closures will be on a daily basis from 8:00am to 5:00pm and will open up for local traffic only after 5pm each day. No street parking will be allowed in the work areas at any time. Please refer to the schedule to ensure your vehicle is moved on

the days road work is taking place in your area. NO PARKING signs will be posted in advance to warn you of impending work. Please observe and obey all traffic controls and posted signs. Drivers should anticipate detours, lane and road closure delays and allow extra travel time while driving through the work areas.

In order to avoid scuffing of the newly paved road, we kindly ask that residents drive carefully and minimize turning the steering wheel while at a stop. Please make turns while moving when possible. Sharp turns while the vehicle is not moving will create larger scuffs that may need patching afterwards. **Please notify your contractors to reschedule any work, such as yard work, while road work is taking place in impacted areas.**

Also, please ensure your sprinkler system is turned off during road work in your area.

Every effort will be made to complete this essential work quickly and with as little inconvenience to your residence as possible. Thank you for your patience and support while we work to maintain the roads in the community.
